Dear Friend of Our Wounded Heroes,

As I sit down to write to you a few months past the holiday season, my heart is still full from the good you and I were able to do this Thanksgiving and Christmas to help our disabled heroes.

During the months leading up to the holiday, we kick it into overdrive to help brighten the holidays for America's War on Terror veterans. Raising money and distributing emergency financial aid, checks for holiday meals, or "Secret Santa" presents for veteran families is truly a rewarding experience.

But the greatest reward comes after the dust settles and messages of gratitude and joy begin to trickle in from the heroes we helped. Often they're powerful enough to move me to tears – stories of hope that are so much greater than you might imagine could come from a simple gift of holiday cheer.

Take, for example, the email we received below from a disabled veteran named Steve M. After we helped Steve and his family – a wife and two young children – with an emergency financial aid check for \$2,200 (\$1,600 in car payments and \$600 for rent), he wrote:

"I'm writing you this email because it's easier for me. If I were to call you right now and tried saying what I want to say to you, I would most likely break down and you wouldn't be able to understand me anyways.

"First, THANK YOU & the Coalition to Salute America's Heroes for helping complete strangers!

"Just when I had given up hope, you called. November was a rough month for my wife and I, a lot of stress, fear and a lot of crying. Last month when all these issues came up <u>I contemplated suicide</u>. I just couldn't see the point of trying so hard anymore when all this bad stuff keeps happening to us.

"When I said you are my 'guardian angel' I truly believe it. You all are amazing people and Coalition to Salute America's Heroes is an amazing organization!"

Let that sink in. The <u>generosity of donors like you</u> kept a veteran family from going homeless and losing their car just a few weeks before Christmas. And it may have even kept a struggling disabled veteran – pushed to the brink of hopelessness – from committing suicide during the holidays.

I hope you'll keep this story in mind as you consider giving again to help a hero's family this Easter. And I hope you know just how grateful I am to have the support of patriotic Americans like you as we do everything in our power to help those who gave so much to defend our freedom.

He Did It: 31 Marathons in 31 Days for Marine Veteran Double-Amputee Rob Jones!

s promised, our good friend Rob Jones completed a terrific feat in 2017: running 31 marathons in 31 consecutive days in 31 cities in America and abroad.

Rob is a Marine Corps veteran who lost both legs to a terrorist's bomb in Afghanistan. He then went on to win a bronze medal in the Paralympics, bike 6,000 miles across the country from Maine to California, and, most recently, run 31 marathons in 31 days – all the while using his journey to raise money for the Coalition and two other organizations that helped him during his recovery.

We're so proud of Rob, his accomplishments, and his commitment to helping his fellow veterans ... and we can't wait to see what he does next!

Your Generosity Helped These Veterans Weather the Storm

Then a crippling natural disaster strikes, its impact is felt for months by those living in its path. But for disabled veterans, many of whom are already unable to work due to their injuries, the path to rebuilding can be even more of a struggle.

In past months we distributed a number of <u>special</u> emergency financial aid checks – assistance for severely disabled War on Terror veterans whose families were devastated by hurricanes and flooding in 2017. You can read a little of their stories – and one very special thank you – below.

The **Texas home of veteran Felix G.** sustained flooding during Hurricane Harvey. Felix and his family were able to stay in their home, but it sustained significant damage including moisture and mold. Felix requested \$1,000.00 to assist with food and gas.

★ Emergency financial aid from Coalition donors: \$1,000.00

Veteran Alex G. from West Virginia was the victim of severe flooding in August. His newly purchased and renovated mobile home incurred water damage due to flooding. His family's congregation and friends volunteered to assist with the repairs, but Alex requested \$2,899.18 to help with the cost of materials and supplies.

★ Emergency financial aid from Coalition donors: \$2,899.18

After Hurricane Irma, **veteran Scott O.'s** home sustained water and debris damage, and his family was unable to move back in until repairs were made. Scott requested \$1,000.00 to assist with food, gas, and a vehicle payment.

★ Emergency financial aid from Coalition donors: \$1,000.00

Army veteran Arnaldo M. from Puerto Rico served our country in Afghanistan. He asked for \$500 for a security deposit on a new apartment after Hurricane Maria devastated Puerto Rico and he and his family became homeless.

★ Emergency financial aid from Coalition donors: \$500.00 **Veteran Rachel S. from Florida** was left homeless after Hurricane Irma. She requested \$1,100.00 to help her pay for an extended stay hotel room, as she did not want to stay in a shelter due to her post-traumatic stress (PTS).

> ★ Emergency financial aid from Coalition donors: \$1,100.00

Veteran Ringner M. from Texas was evacuated during Hurricane Harvey and had to move into a hotel. Ringner needed \$1,000.00 to assist with hotel expenses, food, and gas.

★ Emergency financial aid from Coalition donors: \$1,000.00

Juan's home in Richmond, Texas, was flooded in Hurricane Harvey. His family – including five small children – had to be rescued by boat and move into a hotel because the local shelters were full. The Coalition helped Juan with financial assistance for food and shelter.
