something new on the political scene, a terrible force we have not encountered before. Theirs is not a mere quest for political power and influence. They want nothing less than the total demolition of our values and way of life. Against this malicious tide, we send our best and brightest men and women to do battle whenever and wherever the evil zealots rear their heads around the globe.

Our brave young men and women in uniform are all that stand between us and the agents of chaos and destruction. We owe our survival to these guardians of our heritage. They bear the brunt of the battle on our behalf. They need and deserve our unstinting support.

Today, U.S. counter-terrorism forces are engaging the enemy in dozens of remote nations around the globe. They deserve a prominent place in our hearts and prayers, as do their families who must often contend with the physical and spiritual injuries they incur, the awful legacies of countless battlefields.

We are one of the few organizations that step forward to fill that void – providing direct emergency financial aid to veterans striving to adjust to civilian life with serious injuries and little cash in the bank. In addition to direct financial aid, the Coalition continues to provide an array of vitally needed support for wounded veterans – in particular helping them deal with post-traumatic stress which all too often leads to substance abuse, domestic strife and in some dire cases – homelessness and suicide.

One of the most effective therapies we offer is to bring wounded veterans together to share their experiences and realize they are not alone. To be a part of this process is inspiring. Everyone here at the Coalition is devoted to serving those who bear the burden for our freedom, and we will continue to do so for as long as we enjoy the support of patriotic citizens like you.

As our 2017 IRS 990's and Audit attest, we've recorded one of our best years. We've improved in nearly every financial and qualitative metric -- most notably recording the best administrative costs ever at 6.31%. The BBB hurdle for non-profits is 25%. What's more, our giving increased by nearly 7%. And we're proud to say nearly 80% of our staff are combat-wounded veterans, their spouse or caregiver.

Rob's Month of Marathons generated more than \$ 130,000 for veterans.

The Coalition proudly partnered with Feed the Children again and was able to cover a lot of ground in 2017. Hosting eight food truck events across the nation together we were able to feed over 3,200 veterans and active duty military families in need from California, Kentucky, Arizona, Colorado, Georgia, Texas and Washington, D.C. Hundreds of supporters and volunteers in each community rallied around the mission and we received extra help from some companies like BB&T, Home Depot and Amazon Fresh. In addition to the food and hygiene boxes, we were also able to distribute hundreds of children's books and a special edition James Patterson book to adults.

### **2017 DONATIONS MAKING A DIFFERENCE**

#### **EMERGENCY FINANCIAL AID PROGRAM**

We help severely wounded veterans and their families meet a wide range of day-today urgent financial needs – particularly if they are waiting for their disability benefits to begin (average wait time of 10 months) or have lost income because their spouse or parent had to quit working to become their caregiver. This direct financial aid is used to cover pressing basic expenses such as:

- ★ Utility bills
- ★ Mortgage and rent
- ★ Food and necessities
- ★ Car payments/repairs
- ★ Medical bills
- ★ Home maintenance

### CHANGING VETERANS' LIVES

We verify applications and process payments quickly. (For the sake of their privacy, we do not give their full names.) Some examples of <u>aid requested and fulfilled</u> in 2017:

- Army Spc. Leah B. from San Pedro, California suffers from PTS after serving in Iraq. She needed \$4,340.22 for critical living expenses, including rent and utilities.
- ★ USMC Corporal Jean D. from Jacksonville, North Carolina was paralyzed serving in the War on Terror, and requested \$1,431.45 to cover rent.
- Retired Army Sgt. Daniel H. from Gap, Pennsylvania suffered a traumatic brain injury (TBI) while serving in Iraq. Needed \$1,781.35 to avoid foreclosure and make urgent car repairs.
- ★ Army veteran Aaron M. from Colorado Springs, Colorado was on the verge of eviction and desperately needed \$3,000.

### COALITION PROGRAMS



#### VETERAN CIRCLE MEMBERSHIP

A free membership designed to provide a network for America's combatwounded troops. Qualified members receive numerous benefits including:

being eligible for holiday meal and gift checks, receiving updates of events and employment options across the nation, special discounts, scholarship opportunities and the ability to communicate with other disabled veterans in a private environment.

#### PUBLIC AWARENESS

A major thrust of the Coalition's work is raising awareness of the critical needs faced by many wounded veterans who often must wait months or even years to receive the benefits to which they are entitled. Therefore we engage in a variety of events such as parades, festivals, community events and assorted media appearances described in this publication. We also enlist celebrities who share public service messages for the Coalition.

#### ROAD TO RECOVERY CONFERENCE

An educational and motivational conference for wounded veterans and their families to enable them to approach the future with hope and to be better prepared for the challenges



that lie ahead. The all-expenses-paid program features seminars, workshops and panel discussions where attendees explore resources and services available to them. Experts from government, the private sector and other veteran-focused non-profit groups are also on hand to offer advice and guidance on such topics as; family counseling, career assessment and transition, money management, alternative therapy and personal growth.

#### **GIFT IN KIND**

Our relationship with other non-profit organizations allows us to be the key factor in facilitating the disbursement of donated goods. In 2017, we partnered with Feed the Children and successfully distributed thousands of books and food items to military bases across the nation.

#### **GRANT PROGRAM**

The Coalition provides direct funding to thousands of wounded veterans in need, and also offers grants to other organizations that support disabled veterans and



their families in a variety of ways. For example, in 2017, we provided a grant to Beds for the Brave to supply bed frames and bedding for 50 homeless veterans (shown above). We also proudly provided grants to the Mt. Carmel Center of Excellence, Veterans Court Fund and to Veterans on the Rise for their outstanding support for veterans.

#### HEROES THANKING HEROES

The Heroes Thanking Heroes program (HTH) is a short-term internal employment program that offers severely wounded veterans (who meet certain eligibility requirements), their spouses or caregivers the opportunity to work at home on a part-time basis. The participants have flexible hours and learn valuable skills by working in a virtual call center. More than 230 members of the veteran



community have participated in HTH since inception. Many in the program have found improved motivation and self-esteem as they contribute to the household finances, gain a sense of purpose and develop a supportive peer network.
