

The Heroes Thanking Heroes (HTH) program provides transitional part-time, flexible employment to wounded veterans or their primary caregivers. This flexibility accommodates disabilities and allows caregivers to continue caring for their disabled veteran partners, while providing employment experience and income for their struggling families.

HTH representatives make phone calls from their homes, most often to personally thank donors for their contributions to the Coalition. The program also offers qualified participants some basic training and experience working in a "virtual call center," thereby preparing them for other potential jobs requiring similar skills.

## Salute to Special Heroes: The Marshall Family

am Joy Marshall, a military wife and mother. I work for the Heroes Thanking Heroes (HTH) program while I provide care for my wounded veteran husband, Trey, and my veteran son with post-traumatic stress (PTS). We live in Fort Hood, Texas, an active duty town, as we continue to rebuild our lives after the military following Trey's being severely injured overseas.

Trey enlisted with the United States Army in September 2007 at the age of 28, and deployed to Iraq the following June. His deployment was a high point in his life, and today he misses the comradery with his unit and being able to serve alongside them.

"I'd do it again in a heartbeat," Trey tells me -- but I'm not as sure, as our lives were completely changed when he was wounded by a mortar that hit 35-40 yards away from his Humvee in March 2009. The blast threw him from his gunner's seat and onto the ground at a weird angle. With the heavy gear he was wearing, it was a massive fall, twisting his neck while his body went the other direction. Trey ruptured several discs in his spine and was knocked unconscious for almost 10 minutes. He doesn't remember being injured, only waking up.

Trey was able to complete his year-long deployment,

not realizing the extent of his injuries until he was back home. Some of the challenges he has faced are short-term memory loss, chronic pain, dependency to pain pills, PTS, isolation, and depression.

We've also learned he has severe nerve damage in his body from the blast, and it has been a long process of fighting the VA for the correct treatment. It's been a learning process and a difficult journey at times but after recently seeking care from a clinic we were more comfortable with and him making the decision to come off the opioids, Trey feels healthier than he has in a long time, and is learning what it's like to not be on so much medicine.

On top of Trey's road to recovery, our family also lives daily with the effects of my youngest son returning from Iraq with severe PTS. It's a struggle but having the opportunity to connect with other veteran families has helped. VA appointments are a big part of our lives now so the flexibility of my HTH job and being involved with the Coalition have been huge blessings for me and my family. We've met many wonderful people and gotten to participate in some really cool activities and programs that have helped restore hope for our family.

## Veteran Circle: Coalition's Membership Program for America's Disabled Heroes!

he Veteran Circle membership program is an innovative way for the Coalition to connect with our disabled veterans to help them more effectively. Veteran Circle (VC) offers a wide range of benefits to support our nation's War on Terror combatwounded veterans, including eligibility for holiday meals checks, scholarship opportunities, participation in Skillsoft online education, and updates about local events.

To be eligible for VC membership, a veteran must have sustained an injury during combat in Operation Iraqi Freedom (OIF), Operation Enduring Freedom (OEF), or Operation New Dawn, or in support of those operations in a hostile environment, and have a disability rating assigned by the Department of Defense or the Department of Veterans Affairs of 30% or greater from a single, sustained injury.

If you or someone you know is an OIF/OEF combat-wounded veteran, you can apply for Veteran Circle membership at www.saluteheroes-vetcircle.org.

If you meet the requirements above you are eligible for free membership to the Veterans Circle. Pricing may change in the future but once you join you will not be charged for membership. Cancel your membership at any time by contacting us at 888-447-2588. Becoming a member of VC does not guarantee you will be selected to receive holiday meal checks or scholarships, but it does make you eligible. All members will be screened for approval through our criteria listed above.

Just another reason for veteran families to be a part of our FREE Veteran Circle Membership: our awesome scholarship program! Throughout the year, we award college scholarships to the children of the severely wounded veterans registered to the Veteran Circle program.

During the summer, we change it up and help our families get their little ones into summer camp! These smiling faces are Levi (11) and Lilee (9), the children of John and Jessica from Bowling Green, Kentucky. John is a U.S. Army veteran and Jessica works in our Heroes Thanking Heroes program. Levi and Lilee couldn't have been more excited to attend camp this past summer!

### Combat-Wounded Veterans Gather for Heroes Freedom Weekend

#### **Coalition to Salute America's Heroes hosts 28 married couples at extraordinary event**

his fall, the Coalition hosted over two dozen combatwounded veterans and their spouses from across the nation in New York City for the 2nd annual Heroes Freedom Weekend, a four-day event.

The all-expenses-paid retreat was an extraordinary opportunity for veterans to develop stronger bonds with their spouse, build camaraderie and tour some of America's most sacred and historic landmarks. Among other once-ina-lifetime highlights, participants were led on a tour of the 9/11 Memorial and Museum by retired FDNY Lieutenant Joe Torillo, who was buried twice when the World Trade Center towers fell. Following the tour, the group had a tour with members of FDNY Company 10 in the famed

firehouse at Ground Zero.

"Thousands of patriotic men and women joined the U.S. Armed Forces as a result of the 9/11 terror attacks, and too many of them, like me, returned from the battlefields with life-altering physical and/or mental wounds," said Donny Daughenbaugh, vice president of field operations for the Coalition. "This event was a life-affirming getaway for these couples and was cathartic for all of us."

Last year's inaugural event drew 14 veteran couples and, due to its success, the Coalition doubled this year's participation. With the support of our generous donors, we hope to be able to increase the number of participants in 2019.

I recently lost my vehicle and will be evicted out of my home in three days and I had no idea how I was going to live and where I was going to go. I gave up all hope and was not in a holiday mood. Then I received your letter ... not only did it give me holiday cheer, but it gave me shelter for a couple days during Christmas. It is a good feeling to know that there are people that still care about us even after we have been wounded and can no longer serve. I just want to thank you for this wonderful surprise."
